

Federal Government Ordered to Provide Housing for Veterans with Disabilities

Following a month-long trial in *Powers v. McDonough* – a class action in which we represent a certified class of veterans with disabilities – the firm and co-counsel secured a court judgment and injunctions holding the Department of Veterans Affairs (VA) accountable for failing to provide housing for veterans with disabilities on land intended for that purpose.

The court ordered the VA to timely construct thousands of permanent and temporary supportive housing units for unhoused veterans. In doing so, the court voided VA leases for a baseball complex, a private school's athletic facilities, parking lots, and oil drilling on the land intended to house veterans. Although the federal government and others have appealed, we are proud to have partnered with the National Veterans Foundation and our co-counsel to secure this landmark victory for veterans, and we continue to work *pro bono* on this important case.

"The VA in West Los Angeles ... has for decades strayed from its mission to care for these veterans. Charged with maintaining land deeded to the United States to be used as a home for disabled soldiers more than a century ago, the West LA VA has failed to serve the veterans who served their country. Veterans have seen the government swiftly deploy its resources to send them into conflict, then claim an inability to overcome funding shortfalls and administrative hurdles when they need shelter and housing back at home. The VA for years has failed to provide sufficient housing and has ignored warnings from their own Office of Inspector General and prior federal court rulings that their use of the land was illegal. As Plaintiffs' health deteriorated on the sidewalks of San Vicente, VA officials inside the gates entered into lucrative land deals. Instead of serving veterans, the West LA VA has served its wealthy and powerful neighbors, bowing to private interests backed by lobbyists and engaging in back-room deals and fraud. Leadership at the VA made these choices not to principally benefit veterans, but out of fear of being sued by people with far more resources than unhoused, disabled veterans. After selling and leasing off land given to them in trust, the VA now argues they are out of land to build housing for veterans. The VA's alleged scarcity of land is self-imposed.

What was once a home for disabled soldiers must fully reopen its gates and become a robust community for veterans once again. It is time for the VA's leadership at the highest levels to recognize its obligation and mission statement to care for those who have borne the battle. It is time for the disabled veterans of Los Angeles to come home."

Asylum for Cameroonian Woman Abused by Police

Attorneys: Tom Mahlum, Rajin Olson, Sam LaRoque Partner Organization: The Advocates for Human Rights Over several years, our client was severely and repeatedly abused at the hands of the Cameroonian police for her political activity in support of English speakers, so she fled to the United States and sought asylum. Her asylum application was denied for alleged inconsistencies, and she was placed in immigration removal proceedings. That's when Robins Kaplan took the case *pro bono*.

Cameroon, a country formerly comprised of English and French colonies, is predominantly run by a French-speaking majority that oppresses and marginalizes the English-speaking minority living in Southern Cameroon. We reviewed the evidence about our client's political activities on behalf of the English-speaking minority and the persecution she faced as a result; we noted that the alleged inconsistencies were third-party factual misunderstandings and misstatements, through no fault of our client. Due to a pandemic backlog, our client did not even have a hearing date. We filed a motion to schedule a merits hearing and filed our legal memorandum and evidence with the court, including an expert report on conditions in Cameroon.

At the conclusion of the merits hearing, the judge orally granted our client asylum. The hearing involved our client's painful testimony reliving her experiences, detailed cross-examination from the government, and expert testimony from a country conditions expert the firm found and retained. The court specifically held that our client's testimony was credible and that any alleged inconsistencies in the record were not the fault of our client. The government agreed to waive appeal, providing our client a complete and final victory.

As an asylee, our client no longer faces deportation. She will be able to continue working, and she has a path to eventually be eligible for U.S. citizenship.

Citizenship for Cameroonian Asylee

A former *pro bono* client recently reached out to express her gratitude and let us know that she just became a U.S. citizen!

The client came to the U.S. from Cameroon, where she was imprisoned, mistreated, interrogated, tortured, and raped by prison guards after being arrested for working with the Southern Cameroon National Council (SCNC). The SCNC advocates, through nonviolent means, for the independence of Southern Cameroon - where the marginalized Englishspeaking minority in concentrated. After six months in prison for her work with the SCNC, our client managed to escape. She fled the country and sought asylum in the United States, where she was detained by immigration officials and placed in immigration removal proceedings. The firm spent hundreds of hours preparing for her trial. Despite the government's attempt to undermine her credibility, our trial team succeeded. We obtained asylum for the client, which secured her release from immigration detention, allowed her to remain in the United States, and made it possible for her to become a U.S. citizen.

Asylum for Afghan Contractor for U.S. Department of Defense

Our client and his family operated a company in Afghanistan that contracted with the U.S. Department of Defense. As part of the U.S. military provincial reconstruction team, the company was often subject to Taliban attacks. Our client received threatening phone calls, letters, and visits from unknown men. After receiving numerous threats, the family fled their home, which was subsequently destroyed by the Taliban. Our client then fled to the United States, seeking asylum while the rest of his family remained in hiding. After our client sat through multiple interviews with the help of interpreters, our *pro bono* team applied for asylum and represented him at the asylum interview. Because of the strength of the case and our team's advocacy, we quickly obtained asylum for our client.



Asylum for FGM Victim Fleeing Arranged Marriage

Our client was subjected to FGM (female genital mutilation) in Burkina Faso and later forced into an arranged marriage with a much older man. She came to the United States on a student visa and then applied for asylum and relief under the Convention Against Torture. After waiting over nine years, our client was finally granted asylum in 2024. The grant of asylum is a path to citizenship and a huge weight lifted off the shoulders of our client and her family.

Amicus Brief for Domestic Violence **Scholars** Attorneys: Chris Larus, Sandra Badin, Eric Barstad, Marcus Guith, Raoul Shah Partner Organization: Global Rights for Women

The firm represented a group of domestic violence scholars as *amici* parties before the Minnesota Supreme Court in a criminal appeal that had significant implications for victims of domestic abuse who act in self-defense.

This case involved a victim of domestic abuse on trial for murder after killing her abusive partner on a night he was assaulting her. The jury was instructed that, to find the defendant acted in self-defense, they must find the defendant faced an "immediate" threat of violence, rather than an "imminent" one. The defendant was convicted of second-degree murder and appealed. On review, the Minnesota Court of Appeals reversed the conviction, concluding that the district court's instructions to the jury misstated the law of self-defense and were not tailored to the unique facts of the case. The state petitioned the Minnesota Supreme Court for review, arguing that the district court's instruction was legally correct.

After several *amici* parties, including a group of domestic violence scholars represented by Robins Kaplan, requested to participate in the appeal, the state abandoned its claim that the district court's instruction that "imminent" means "immediate" was appropriate. As a result, the Minnesota Supreme Court dismissed the appeal, and the Minnesota Court of Appeals' reversal of the conviction stands. This is a significant win for domestic abuse survivors everywhere.

Medical Records Review Helps Secure Dismissal of Charges Against Refugee

The firm recently helped the Legal Rights Center, a nonprofit public defender, obtain dismissal of assault charges against a refugee who would have suffered devastating immigration consequences if convicted. One of the firm's medical analysts reviewed medical records for the case and concluded that no medical documentation supported a conclusion that trauma had caused the injury, not infection. The case was dismissed after the public defender shared this analysis with the prosecutor.


Pro Bono Legal Clinic Helps Low-Income Minnesotans in Insurance Disputes

For over 10 years, Dick Allyn has taught at the University of Minnesota Law School Insurance Law Clinic, which provides legal assistance to low-income clients in insurance cases. Clients come to the clinic when they are facing a crisis in their life because of medical issues, loss of property, or liabilities to third parties, for which their only recourse is insurance coverage. This unique clinic is the only law school insurance clinic in the nation, and it covers an important access-to-justice gap, since legal aid programs do not generally help clients with insurance matters.

In recent years, Dick and his students have obtained favorable results for dozens of low-income clients. The clinic favorably settled a claim for a cancer survivor who was told – after the fact - that only their hospital stay, not the surgeon, was covered by medical insurance. In another case, the clinic sued and recovered funds from a property insurance company and agent who denied coverage to a recently divorced mother of three children after the family home, which was on the market, burned down. Firefighters were blocked from the fire scene by her ex-husband who held a gun; as police arrived, he shot himself. When the client went to collect the property insurance to begin to rebuild her life, she was denied and told that her ex-husband had removed her from the policy. The clinic also recently represented a client experiencing homelessness who needed the bulk of his teeth removed and replaced by implants after he was denied coverage despite working hard to get the money together to pay a dental insurance premium.

In 2021, Robins Kaplan took on the *pro bono* representation of a low-income tenant whose landlord failed to keep their rental property in repair. The case went to a five-day trial in housing court in early 2022. We represented the tenant and successfully obtained a judgment against the landlord for the deplorable conditions of the property. Notably, the judge found the landlord had submitted to the court a fraudulent lease showing the faked signature of our client; Robins Kaplan worked with a handwriting expert to prove the document was false, which the court incorporated into its findings.

In retaliation against this trial victory, the landlord kept the tenant's security deposit. The firm then helped the client obtain a judgment against the landlord for unlawfully retaining her security deposit. However, the landlord refused to pay both judgments, and instead began filing retaliatory conciliation court lawsuits against our client (all without serving our client) to obtain default judgments without our client even knowing the cases had been filed.

By 2024, the landlord still had not paid the judgments. After several motions, court appearances, and wins before two separate judges to ensure the judgments reflected proper accrued interest, and after successfully obtaining dismissal with prejudice of the landlord's retaliatory cases, we collected both judgments from the landlord, with interest, despite the landlord's attempt to transfer and hide assets.

Settlements Allow Formerly Homeless Client to Remain Housed

The firm obtained a very favorable settlement for a low-income client in an eviction case after thoroughly investigating the landlord's allegations of breach of lease and demanding a jury trial. Our client was homeless for many years before moving into her home with the assistance of a housing subsidy for individuals living with HIV/AIDS. The landlord filed an eviction against the client, alleging breach of lease and claiming the client had threatened a utility worker, which resulted in our client's arrest. Our investigation revealed that police had been called because the utility worker was frightened of our client's dog and had threatened the dog with a screwdriver. Our client was not arrested for anything related to this incident. After we shared the results of our investigation and demanded a jury trial, the landlord quickly agreed to allow our client to continue to live in her home. Unfortunately, the landlord continued to try to evict the client for unrelated reasons. But, with this additional time, our client was able to locate other housing, so we negotiated a second agreement that provided her with the funds necessary to move, which enabled her to maintain attain safe, stable, affordable housing.

Expungement Clears Way for Brighter Future for Low-Income Mother and Daughter

The firm recently helped a low-income client obtain expungement of three misdemeanor criminal cases. The criminal cases – one of which was dismissed without a conviction – were preventing our client from obtaining better employment to support herself and her young daughter. When our client came to us for pro bono representation, she had already had multiple job offers rescinded after a background check revealed her misdemeanor cases. We filed motions for expungement in all three cases, providing the court with extensive information about the client's efforts to improve her life and about the record's debilitating impact on her efforts to obtain employment. The court granted all three of our requests. In expunging these cases, the court found that our client took responsibility for her actions and that she does not pose a risk to society. Our client is hopeful expungement will allow her to obtain better employment and one day pursue her dream of joining the U.S. Air Force.
