PRO BONO

CLASS CERTIFICATION GRANTED IN CASE FOR VETERANS EXPERIENCING HOMELESSNESS

Our *pro bono* case team recently obtained class certification in *Powers v. McDonough*. This class action against the federal government on behalf of unhoused veterans alleges claims of disability discrimination, breach of duty as trustee of a charitable trust, and violations of the West Los Angeles Leasing Act and Administrative Procedure Act.

Over a decade ago, with the assistance of other counsel, our clients – unhoused veterans with severe disabilities – sued the federal government for failure to provide housing on grounds that were gifted to the United States as a home for wounded veterans. The federal government settled those claims by agreeing to build 1,200 permanent supportive housing units for veterans on the grounds with half of those units to be built by 2022. In 2021, the Veteran's Administration Office of Inspector General reported that the government had not built any of these units and that "[The} VA envisions all phases of construction will be completed in the next 17 years." Because the government did not keep its promise, the firm brought this lawsuit in late 2022. With class certification obtained, our case team is now preparing for trial.
